Requirements:

- The event shall be for horses between three (3) and seven (7) years of age.
- All participating owners and riders must be members of the NCHA.
- Use all applicable NCHA Rules. Permission to use local exceptions will not be unreasonable withheld.
- Pay NCHA an approval fee based on total entry fees collected
 - \$9,999 or less in Added Money – 8%
 - \$10,000-\$99,999 in Added Money – 3.5% (no monitor required)
 - \$100,000 added or more (monitor required) – 2% + \$500 approval fee per show day
 - Approval fees may be deducted from total entry fees collected. The approval fee of \$500 may be pro-rated between classes held that day.
- Cattle
 - Provide at least three (3) head of “fresh cattle” per work.
 - At Limited Age Events with less than \$750 in added money that are held in conjunction with a weekend show, show management has the option to provide 2 ½ head of cattle.
- Judges requirements are available on last page of this application.

- Use NCHA Approved Judges
 - All events must be videoed, and files/tapes held for 30 days.
 - All events with \$100,000 added or more must use no fewer than five (5) AAA judges or AAAA judges. These events will be monitored.
 - A show must sign AMS agreement to furnish necessary equipment, lodging, meals and ground transportation for NCHA monitor.

- Judges may judge up to 13 consecutive days at Limited Age Events. Additional judging days must be approved by the Director of Judges
- NCHA Adjusted Monitor System

- NCHA will solicit judges for all shows using the Adjusted Monitor System

- Only the accumulative score will be posted in the arena. No individual scores will be available anywhere, except a copy of the official judge's cards, which will be posted on the following day or at the competition of the go-round.
