Official Rules

1. **HOW TO ENTER**. Purchase an NCHA Raffle ticket from any NCHA/NYCHA Designated Member or NCHA Staff and be entered for a chance to win.

Tickets are \$100 each.

Entry must include entrant's name, physical address, city, state, zip code, phone number and email.

No facsimiles, mechanical reproductions or alternate form of entries will be accepted.

ALL ENTRIES MUST BE RECEIVED BY OCTOBER 9, 2021 12:00pm. THE DRAWING WILL BE HELD AT THE BRAZOS BASH, WEATHERFORD, TX. UNLESS OTHER CIRCUMSTANCE PRESENT THEMSELVES TO CHANGE LOCATIONS.

- 2. **SCHEDULE.** Drawing will be held during the Brazos Bash held in Weatherford, Texas tentatively October 10, 2021. The deadline to submit entries will be October 9, 2021 12:00pm.
- 3. **DRAWING.** From among all eligible entries, winners will be selected by random drawing, to be held on or about October 10, 2021 during the 2021 Brazos Bash in Weatherford, Texas unless other circumstances present themselves to change locations. The National Cutting Horse Association, whose decisions are final and binding in all respects, will conduct the drawing. By participating, entrants agree to be bound by the Official Rules, and the Sponsors' decisions. The drawing will consist of all eligible entries received. Winners will be contacted using the information on entry blank to select prizes in the order in which they were drawn. Winners need not be present at the 2021 Brazos Bash.
- 4. **PRIZE, ODDS OF WINNING**. Winners will receive 1 of 3 entries to the 2022 NCHA World Championship Futurity.
- All winners must declare class prior to October 14th, 2021 or prior to the first payment due for the 2022 NCHA World Championship Finals.
- Slot can be sold once prior to the first payment due date (October 14,2021) for the 2022 NCHA World Championship Finals.

Winners are solely responsible for all unspecified expenses associated with registering, claiming or using the prize, including but not limited to taxes, insurance, or other fees.

Odds of winning depend upon number of eligible entries received. Winners will be notified by phone, text and/or by mail.

5. **ELIGIBILITY.** Persons in any of the following categories are not eligible to participate or win the prizes: (a) persons who are employees of The National Cutting Horse Association or independent contractors of the above organizations; (b) persons who are engaged in the drawing of the winner for this Raffle; (c) persons who are immediate family of any person in either of the preceding categories.

Decisions of NCHA with respect to the Contest are final. NCHA reserves the right to amend, suspend or terminate the Contest at any time, which will become effective upon announcement. NCHA reserves the right, at its sole discretion, to disqualify any individual who (a) tampers with the entry process or the operation of the Contest; (b) attempts to forge an entry form or to otherwise submit a fraudulent prize claim; (c) acts in violation of the Official Rules; or (d) fails to fully comply with the directions of the Contest Officials.

6. **CONDITIONS OF PARTICIPATION.** Sponsor is not responsible for illegible, incomplete, late, lost, damaged, destroyed, delayed or misdirected entries, unintelligible or garbled entries. Once submitted, entries become the sole property of the National Cutting Horse Association and will not be returned. No substitution or cash equivalent of prize. WinnerS will be required to sign and return an Affidavit of Eligibility, a Liability Release and a Publicity Release (where legal) within 10 days of contest ending date. If, for any reason, all required documents are not executed and returned within 10 days, such a winner will be disqualified, with an alternate winner being selected. **Winners will be solely responsible for any and all applicable taxes associated with prizes.**

Any drawing may be postponed due to weather or any state of emergency declared by the Mayor of Weatherford, The Governor of Texas, or the President of the United States. In such an event, a new date, place and time for the drawing will be determined by NCHA, which will be announced on NCHA's website.

United States Tax Requirements:

Winners will be required to provide a properly completed and signed Internal Revenue Service (IRS) Form W-9 prior to receiving prizes. The winner will be issued by the NCHA a 1099-MISC for the value of the prizes; the winner will be responsible to pay all applicable federal and state income taxes as a result of winning the 2021 NCHA World Championship Futurity Raffle. Should winner refuse to provide the NCHA with a properly completed and signed IRS Form W-9, winner forfeits his or her right, interest, or title to the prizes. Winner may

Winners who are a Nonresident Alien for U.S. income tax purposes will be required to properly complete and sign Parts I & IV of Form W-8BEN: Certificate of Foreign Status of Beneficial Owner for United States Tax Withholding. Winners are subject to immediate IRS income tax withholding of 30% of the value of the prizes, prior to the prizes being awarded to the winner, winner must pay to the NCHA in U.S. Funds 30% of the fair market value of the prize. NCHA will remit the tax payment (30% of fair market value) to the IRS and issue the winner an IRS Form 1042-S (Foreign

Person's U.S. Source Income Subject to Withholding). Should winner refuse to properly complete or sign a Form W-8 BEN, winner permanently forfeits his or her right, interest, or title to the prize.

By participating, entrant (a) agrees to abide by and be bound by these Official Rules and the decisions of NCHA, which is final and binding in all respects; (b) releases and agrees to hold harmless National Cutting Horse Association, or their respective parent companies, affiliates and subsidiaries, officers, directors, shareholders, agents and employees from any and all liability whatsoever arising from entrant's participation in Contest or the acceptance, receipt, possession or use/misuse of any prize. By accepting prize, where permitted by law, winner grants (such grant to be confirmed in writing upon NCHA's request) to NCHA and NCHA's designees, the right to print, publish, broadcast and use, worldwide in any media now known or hereafter developed, including but not limited to the world wide web, at any time or times, the winner's name, portrait, picture, voice, likeness and biographical information as news or information and for advertising, trade and promotional purposes without additional consideration, and without further review, approval or notice. By accepting prize, winner further agrees, without such additional compensation, that winner shall appear for any presentation or other activity which may include filming/audio/video/electronic or other recordings and/or interviews, as may be determined from time to time by NCHA in its sole discretion. Notwithstanding foregoing, Winners agree that NCHA shall not be obligated to advertise or promote winner. As a condition of participating in the Contest, entrant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Contest shall be resolved individually, without resort to any form of class action, exclusively, before a court located in the City of Fort Worth, having competent jurisdiction, which Court shall apply the laws of the State of Texas, without regard for doctrines of Conflict of Law of Texas or any other jurisdiction.

BY PARTICIPATING IN CONTEST, ENTRANT FURTHER WAIVES ANY RIGHT HE/SHE MAY HAVE TO A TRIAL BY JUDGE OR JURY. Further, in any such dispute, under no circumstances will entrant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (that is, costs associated with entering this Contest), and entrant further waives all rights to have damages multiplied or increased.

Should any term in these Official Rules be deemed by a court of competent jurisdiction to be void, unenforceable or contrary to law, such term shall, but only to the extent necessary to bring this Section within the requirements of law, be deemed severed from the remainder of the terms in this Section, and the remainder of the Official Rules shall be given effect as if the severed term were not included herein.
