

NCHA EXECUTIVE COMMITTEE CONFERENCE CALL MINUTES APRIL 6, 2023 6:00PM Central

A conference call of the Executive Committee of the National Cutting Horse Association was held on Thursday, April 6, 2023, beginning 6:00PM central time.

All Executive Committee members were present: President Ted Sokol, President-Elect Toddy Pitard, Vice President Mark Senn, Kristen York, Rock Hedlund, Kirby Smith, John Lavelle, Sharon Overstreet, Tommy Williams, Skip Jones, Kathleen Moore, Ernie Beutenmiller, Cara Brewer, and Casey Green. The Executive Committee meeting was called to order at 6:01PM and roll call was taken.

President Ted Sokol addressed the members of the Executive Committee with the purpose of the call to continue the discussions on the proposed payouts for the 2023 Metallic Cat World Championship Futurity.

FUTURITY PROPOSED PAYOUT STRUCTURE

Executive Director Jay Winborn provided an update to the Executive Committee with regard to the 2023 Metallic Cat World Championship Futurity and the payouts. Jay expressed thanks for everyone getting on the call and confirmed that each member had received the proposed payout model.
